PROSPECTUS FOR B.V.Sc. & A.H. DEGREE COURSE 2023-24

PART - I

1. PREAMBLE

Maharashtra Animal and Fishery Sciences University, Nagpur has been constituted under of Maharashtra Animal and Fishery Sciences University Act, 1998 (Maharashtra Act XVII).

Executives of the University

- i) Hon'ble Governor of Maharashtra State and Chancellor of Maharashtra Animal & Fishery Sciences University, Nagpur.
- ii) Hon'ble Minister of Animal Husbandry, Dairy Development and Fisheries, Maharashtra State and Pro-Chancellor of Maharashtra Animal and Fishery Sciences University, Nagpur.
- iii) Hon'ble Vice-Chancellor, Maharashtra Animal and Fishery Sciences University, Nagpur.

In exercise of the powers conferred upon University vide provision in section 5 (Chapter II) of the MAFSU Act, 1998, admission to the degree programme in the faculty of Veterinary Science shall be held in accordance with the following regulations.

2. COMPETENT AUTHORITY

The Registrar, Maharashtra Animal and Fishery Sciences University, Nagpur shall be the Competent Authority for admissions. However, the Associate Deans of Nagpur Veterinary College, Nagpur; Mumbai Veterinary College, Mumbai; KNP College of Veterinary Science, Shirwal; College of Veterinary & Animal Sciences, Parbhani & College of Veterinary & Animal Sciences, Udgir shall be responsible officer for effecting the admissions. The decision of the Competent Authority shall be final.

3. DEFINITIONS

- i) **'Candidate'** means an applicant who desires to seek admission to first year B.V.Sc. & A.H. Degree Course in Maharashtra Animal & Fishery Sciences University, Nagpur.
- ii) **'Veterinary College'** means the college to impart Veterinary education in Maharashtra state as prescribed by Veterinary Council of India Regulations.
- iii) **'Competent Authority'** means the authority empowered to invite the applications and effect admissions as per rules.



- iv) **‘Intake Capacity’** means the number of sanctioned seats.
- v) **‘VCI Regulation (2016)’** means the MSVE-2016 regulations made by the Veterinary Council of India in exercise of the powers conferred by sub-section (4) of section 22 read with clause (b) of subsection (1) of section 21 of Indian Veterinary Council Act, 1984; (52 of 1984).
- vi) **‘Professional Year’** means a period consisting of minimum 210 instructional days excluding annual examination days except fourth professional year which consists of 315 instructional days excluding annual examination days and Internship.
- vii) **‘Syllabus and Curriculum’** means the Syllabus and Curriculum for courses of study as specified by the Veterinary Council of India.
- viii) **Syllabus** comprises of 81 credits as minimum requirement for a programme leading to Bachelor of Veterinary Science and Animal Husbandry Degree.
- ix) **Veterinary Curriculum** includes core courses and internship training programme including enterpreneurial training.
- x) **‘Credit Hours’** means the weekly unit of work recognized for any particular course as per the course catalogue issued by the University. A lecture class of one hour per week shall be counted as one credit of theory, whereas a practical class of two hours duration or a working period of three hrs. in the TVCC or LFC per week shall count as one credit hour for practical.
- xi) **‘Degree Course’** means a degree course of Bachelor of Veterinary Science and Animal Husbandry shall comprise of a course of study consisting of curriculum and syllabus in part IV of these regulations spread over five complete professional years including a compulsory internship of ‘one year’ duration undertaken after successful completion of all credits as prescribed in the syllabus.
- xii) **‘Internship’** means the full-time training of one year duration in Veterinary and Animal Husbandry service including emergency duties and enterpreneurial training undertaken after successful completion of all credits as prescribed in the syllabus.
- xiii) **‘NEET-UG-2023 Score’** means a total of the marks in PCB group secured by the candidate in National Eligibility Cum Entrance Test (NEET-UG-2023) conducted by National Testing Agency, New Delhi.



- xiv) **'Agriculturist'** means a person who owns land and whose main source of income is derived from personal cultivation of agriculture land, the area of which does not exceed the economic land holding as defined in Tenancy and Agricultural Land Act of the revenue region he / she belongs to.
- xv) **'Constituent Colleges'** means the Veterinary Colleges at Nagpur / Mumbai / Shirwal / Parbhani / Udgir.
- xvi) **'Counsellor'** means an academic officer who will help a batch of students assigned to him / her in planning of their studies and foster close personal relationship.
- xvii) **'Qualifying Examination'** means Higher Secondary (10+2) examination or equivalent examination.

4. THE ELIGIBILITY / SELECTION CRITERIA FOR ADMISSION

- (1) XIIth Std. passed in 10+2 pattern or an equivalent Examination with minimum **50% marks in Physics, Chemistry, Biology or Biotechnology and English taken together** for **Unreserved** category and **47.50% marks in case of Reserved category candidate**.
- (2) The admission of candidate to B.V.Sc. & A.H. degree course shall be made on the basis of his / her merit in the **National Eligibility Cum Entrance Test (NEET-UG-2023)** conducted by National Testing Agency, New Delhi
- (3) The candidate should have completed minimum 17 years and should be below 25 years of age on or before **31st December, 2023**. However, the relaxation of maximum age by 5 year shall be considered for constitutional reserved category candidates.
- (4) English shall be the medium of instruction & examination for B.V.Sc. & A.H. degree course.

- Note :** a) Qualifying examination shall be XII Std. or equivalent examination as specified in VCI regulation 6(b) such as CBSE or Indian School Certificate Examination with English (NCERT norms) and physics, chemistry and biology or biotechnology including practical test in these subjects or recognized equivalent there to by the Association of Indian Universities or by the appropriate authorities.
- b) The candidates who have passed the XIIth Std. Examination / qualifying/ equivalent examination should have offered Physics, Chemistry, Biology or Biotechnology and English subject.

Note :

- i) **University Quota seats** - 70% seats of University quota at each constituent college shall be filled in as regional quota (R-quota) as per regional merit list while remaining 30% of the seats of total intake capacity shall be filled as state quota (S-quota) as per common state merit list prepared by the University.
- ii) **VCI Quota seats** - 15% of total intake capacity of each Veterinary College shall be filled in by Veterinary Council of India (VCI), New Delhi through its independent admission procedure. VCI seats within intake capacity (mentioned as per #) if remained vacant after VCI admissions will be filled in by regular candidates as per the state merit list in last round of admission. VCI seats within intake capacity (mentioned as per # + ##) if remained vacant after VCI admissions will be filled in by regular candidates as per the state merit list in last round of admission subject to approval of Government of Maharashtra (**mentioned as per *****).
- iii) **J & K and Ladakh UT Quota seats** - One seat over and above the intake capacity at each Veterinary College shall be filled from the wards of citizens displaced due to terrorist activities from Jammu & Kashmir Union Territories and Ladakh Union Territories and also from the wards of officers belonging to Indian Administrative Services, Indian Police Services and other officers and staff belonging to military and paramilitary forces transferred to Jammu & Kashmir and Ladakh Union Territories to deal with terrorist activities as per Govt. Resolution No.AGU-2095/23106/CR-181/19-a, dated. 5th September, 1996 and No.AGU /1197/28688-CR-94/97/19-a, dated 27th October, 1997. Such candidates should secure minimum 50% marks in Physics, Chemistry, Biology or Biotechnology and English taken together at 12th or equivalent examination. However, the admission shall be made only on the basis of his / her merit in the National Eligibility Cum Entrance Test (**NEET-UG-2023**) conducted by National Testing Agency, New Delhi.

The candidate shall have to apply online for the admission and also take print out of application form. The candidate shall then send the hard copy (print out) of application form along with self-attested copies of all required documents to the Nodal Officer of concerned Union Territories for admission of migrants **i.e. The Tahsildar, Headquarter Assistant to Relief Commissioner (M), Canal Road, Jammu Tawi – 180 001 (J & K and Ladakh Union Territories)**. The Nodal officer will verify the Migration / Displacement Certificate of the candidates and only valid application



may be forwarded to **“The Registrar, Maharashtra Animal & Fishery Sciences University, Futala Lake Road, Nagpur-440 001 (M.S.) so as to reach on or before 07/07/2023.**

- iv) **Goa Quota seats** - Five seats over and above the intake capacity at Mumbai Veterinary College, Mumbai; Four seats at KNP College of Veterinary Science, Shirwal and Two seats at College of Veterinary and Animal Science, Parbhani for B. V. Sc. & A.H. Degree Course are reserved for Goa State candidates. They must secure minimum 50% marks in the subjects of Physics, Chemistry, Biology or Biotechnology and English taken together at qualifying examination i.e. XII Std. or equivalent. However, the admission shall be made only on the basis of his / her merit in the National Eligibility Cum Entrance Test **(NEET-UG-2023)** conducted by National Testing Agency, New Delhi. The candidate shall have to apply online for the admission and take print out of application form. The candidate shall then send the hard copy (print out) of application form along with self attested copies of all required documents to the Directorate of Animal Husbandry and Veterinary Services, Pashusamvardhan Bhavan, Patto, Panaji, Goa - 403 001 who will verify the candidature and communicate to the University.
- v) **NRI/FN/PIO/OCI Quota seats** - Total 10 seats over and above the intake capacity of B. V. Sc. & A.H. Degree Course are reserved for NRI/FN/PIO/OCI candidates (Please refer Sr. No. 9 on page 18 & 19 for details).

These seats if remained vacant, will be filled in during special round of admission by candidates from the state merit list. Such desirous candidate from state merit list shall have to fill up an online option form during special round by paying Rs.5000/- through online payment gateway. If got admitted, the special fees applicable to NRI/FN/PIO/OCI candidates (10,000 U.S. \$ per professional year in addition to the regular fee) will be charged to such students. Once the candidate secures admission under this category, he/she shall have to pay the fees (special + regular fee) alike NRI/FN/PIO/OCI candidate throughout his/her Degree course of study. Special fee paid by the candidate shall not be refunded in any case.



6. RESERVATION OF SEATS

All reservations are given on the basis of percentage notified by the Maharashtra State Government for respective categories and policy of the Government declared from time to time.

6.1 Unreserved seats will be **40%** of total intake capacity.

- 30% seats shall be reserved for female candidates from unreserved as well as reserved category.
- **Physically Handicapped** : 5% seats will be filled in from the total intake capacity as per their merit and as per the procedure laid down in GR dated: 11/07/2019
- **Orphaned Candidate** : 1% seats will be filled in from the total intake capacity as per GR dated:11/07/2019
- 2% seats shall be reserved for Special Backward Class (SBC) candidates and will be filled in during second round of admission at Step IV [See Page No.23 (xxiv)]



NOTE:

- i) Caste certificate and Caste/Tribe validity certificate issued by the Competent Authority shall be considered for benefit of reserved category.
- ii) With reference to the order given by Hon'ble Supreme Court Civil appeal No.11234-48/2017, candidates from SC, ST, VJ/DT(a), NT(b), NT(c), NT(d), OBC and SBC should provide Caste Validity Certificate. However, Candidates belonging to the categories of backward classes shall be required to submit the caste certificate and Caste/Tribe validity certificate (CVC) or proof of submission of proposal to competent authority for obtaining 'Caste Validity Certificate' along with the application form.

The candidates provisionally allotted the seats under reserved category shall be required to submit CVC upto **17/08/2023** in admitted college, failing which their provisional admission shall automatically stand cancelled without any prior notice. Such candidate however, shall be considered under unreserved category for admission during second rounds onward provided he/she fulfills the eligibility criteria.

The candidates belonging to reserved category who has not submitted CVC along with application form and not allotted the seats during 1st round, shall have to submit CVC on or before **17/08/2023** failing which, their candidature shall be considered under unreserved category provided he/she fulfills the eligibility criteria.

- iii) The candidate should claim the applicable reservations in the application form.
- iv) A candidate claiming benefit of reservation under the categories of VJ/DT(a), NT(b), NT(c), NT(d), OBC, and SBC shall be required to enclose Valid Non-Creamy Layer Certificate in the name of parent or guardian (only if either parents are not alive) as specified in the Government Resolution No.CBC-10/2006/CR-15/MVK-5 dated 5th June, 2006, otherwise their candidature will be considered under Unreserved category, provided they fulfill the eligibility criteria for unreserved category and submits the grievance along with difference of application fees Rs. 300/- in addition to grievance fees.
- v) Candidates belonging to 'Creamy Layer' amongst the Categories of VJ/DT(a), NT(b), NT(c), NT(d), OBC and SBC must note that the provision of reservation is **NOT** applicable to them.



- vi) The Non-Creamy Layer Certificate issued by the competent authority on or after **1st April, 2023** or valid upto the last date of submission of application form will considered otherwise the claim of reservation shall be rejected.
- vii) The SBC candidates belonging to non-creamy layer will be admitted as per the provision made in GR.No.TEM-3397/12926/(9086) TE-1 dated 11-7-1997. The adjusted reservation of Special Backward Class (SBC) will be 2% of intake capacity and will be filled in during second round of admission at Step IV [See Page No.22 (xxiv)].

(A) Agriculturist Certificate (AG) :

Certificate of Agriculturist for the year **2022-23** issued by Tahsildar / Naib Tahsildar on or after **01/04/2023** stating that the applicant or his/her parents or paternal grandparents is/are owner holding agricultural land and whose main source of income is derived from personal cultivation of agricultural land will be considered.

The claim of AG reservation shall be rejected if the main source of income is derived from other source and not from personal cultivation of agricultural land. Proforma of this certificate is at **Annexure IV** of the prospectus.



(B) Freedom Fighter Certificate (FF) :

A certificate of the freedom fighter of the applicant's parent / paternal grandparents issued under the signature of Hon'ble Prime Minister/ Chief Minister of Maharashtra State will be considered. If the certificate is issued in the name of parent (FF) OR grandparent (FF), the claim of reservation will be granted provided, the applicant has attached fresh affidavit of parent (FF) OR grandparent (FF) OR if freedom fighter is not alive then affidavit signed by Wife/Husband of FF will be considered on a stamp paper of Rs.100/- issued / purchased on or after 1/4/2023 stating the following points.

- (a) Applicant is son/daughter of Freedom Fighter (Parent) OR grandson/granddaughter of Freedom Fighter (grandparent).
- (b) Freedom Fighter has not used this concession for any relative here before.
- (c) Freedom Fighter shall not use the concession for any relative here after, if the benefit is availed at this time.

(C) Project Affected Person Certificate (PAP) :

The certificate of project affected person issued by District Re-settlement officer/ Rehabilitation officer in the prescribed format as per **Annexure V** of the prospectus will be considered.

Claim of reservation under PAP category can be considered for his / her, son / daughter / brother / sister / grandson (paternal) / granddaughter (paternal) / nominated by project affected person. If the land of applicant / applicant's parent / applicant's grandparent has been acquired by the Government for MAFSU / SAU / Irrigation / Power / Defence project, the benefit shall be given to them for the purpose of education vide Government Resolution RPA-3995/C.N.-183/R-1 Mumbai, Dated 22nd May, 1996. **The name of the beneficiary candidate must have been mentioned in the Project Affected Person's Certificate issued by the competent authority.**



(D) Defence Personnel Certificate (DP) :

Claim of reservation shall be granted to the children (applicant) of Defence service personnel, Ex-defence service personnel including those permanently disabled or died in action.

Candidate should be a son/daughter/widow of the person who has been a member of the Armed Forces of India and who has put in at least 5 years Active Service and has been subject to Indian Army act, Indian Navy Act, Indian Air Force Act and also includes Ex-Serviceman who retired, from such service or permanently disabled or died in action. The condition of minimum active service of 5 years shall not be applicable to the service personnel who are permanently disabled or died in action.

The candidate shall be required to produce a certificate from the appropriate Authority of the Armed Forces in the rank of Commandant or equivalent or from District Sainik Welfare Office/Board certifying that the candidate fulfils the above conditions.

6.4 Reservation for female candidates

- i) 30% seats shall be reserved for female candidates, as per G.R. No. MED-1300/CR-271/2000/EDN-1 Mumbai 5th June, 2000. The seats so reserved shall be available for all the categories like Unreserved, EWS, SC, ST, VJ/DT(a), NT(b), NT(c), NT(d), OBC & SBC.
- ii) If required number of female candidates are not available in a particular category then these seats shall be offered to male candidates of that particular category during second round of admission as per the procedure given.



6.5 Reservation for Physically Handicapped candidates (PH) :

Physically Handicapped candidates shall not be admitted to B.V.Sc. & A.H. degree course, if he / she suffer disabilities in physical fitness as listed below -

- a) Disability of total body including disability of chest / spine more than 50%.
- b) Disability of lower limb of more than 50%.
- c) Disability of upper limb.
- d) Visually handicapped candidates and those with hearing disability.
- e) Candidates with progressive diseases like myopathies etc.
- f) Disabilities which otherwise would interfere in the performance of the duties of a Veterinarian.

The disability should be certified by Civil Surgeon / Medical Board and the candidate has to present him / herself before the Civil Surgeon / Medical Board. The last valid disability certificate of the candidate issued by Civil Surgeon / Medical Board should not be more than three months old from the date of submission of application form, failing which the claim of Physically Handicapped candidature shall be rejected. The candidate should submit the Physically Handicapped Certificate as per proforma in **Annexure VI**. The type of disability and the percentage of disability should be readable / clearly legible to ascertain the eligibility for admission.

6.6 Reservation for Orphaned candidates (OC):

One percent (1%) seats of the total intake capacity will be reserved for the orphan candidate. These seats shall be filled by competent authority as per Government Resolution, Women & Child Welfare Department, No.AMJ-2011/C.R. 212Desk 3, dated 2 April 2018 and the policy of the Government declared from time to time.

6.7 Reservation for Economically Weaker Section Candidate (EWS):

Ten percent (10%) seats of the total intake capacity will be reserved for the Economically Weaker Section Candidate (EWS) as per Government Resolution dated 11/07/2019. These seats shall be filled by competent authority as per the provision mentioned in the Government Resolution No. राआधो- 4019/प्र.क्र.31/16-अ, dated 12/02/2019 and क्र. राआधो ४०१९/प्र.क्र.३१/१६-अ,



दिनांक-२३ डिसेंबर, २०२०. The candidate should submit the EWS certificate (Eligibility Certificate for Economically Weaker Section **valid for 2023-24**) signed by competent authority as per proforma **strictly** given in **Annexure-VII**.

Note: Claim under EWS category will not be accepted for Candidate submitting Income & Assest certificate.

7. IMPORTANT INSTRUCTIONS TO CANDIDATES

A. IMPORTANT INSTRUCTIONS REGARDING FILLING AND SUBMISSION OF APPLICATION FORM

- i) Candidate is required to visit the website (**www.mafsu.ac.in**) & click on B.V.Sc. & A.H. degree course and download the soft copy of the prospectus. The candidate should read the prospectus carefully before filling the online application form. The desirous candidate shall apply online for the purpose of admission.
- ii) Further, under B.V.Sc. & A.H. degree course, the candidate shall log in as new user and shall fill in the required details, pay the processing fees, upload all the required documents (scanned copies of original documents), photograph, signature etc. and shall submit the details by clicking on the “**Submit**” link.
- iii) **Modes of Payment for Application Fees :**
 - 1) The application fees for **Unreserved** candidate is **Rs.1000/-** and for **Reserved** candidate is **Rs.700/-**.
 - 2) The candidate from the **states other than Maharashtra** shall have to pay **Rs.1000/-**.
 - 3) Candidate shall pay the requisite application fees through online mode.
 - 4) Fees once paid will not be refunded due to any reason.
- iv) If the application form is incomplete in any respect and/or if the essential documents are not uploaded till the due date specified by University for resubmission, it will ultimately lead to rejection of the application form or non-acceptance of claim of reservations.
- v) The candidates are advised to furnish accurate information in all the columns. The University shall not be responsible for any such discrepancy appearing in the application form which may result in deciding



disadvantageous merit position of the applicant. Certificate /document issued by the Competent Authority will only be considered.

- vi) If any document/certificate is in language other than Marathi / Hindi / English, a translation in English duly certified by the competent / issuing authority should be necessarily uploaded attached.
- vii) If certain document/certificate to be attached is having more than one page (eg. NCL certificate, Marksheets for more than one attempt, etc.) then it shall be uploaded together by converting them in one PDF or JPEG file.
- viii) Candidates are advised to use desktop, laptop only with proper internet connection while filling the application form. **Further advised not to use mobile phones for filling the application form or at any stage of admission programme.**
- ix) For detail admission procedure please refer the application flow (**Annexure-XIII**).

B. OTHER IMPORTANT INSTRUCTIONS

- i) Candidates are required to ascertain their eligibility and to submit the required documents/certificates along with application form to make them eligible for selection process on merit basis and claim of reservations.
- ii) The candidates who have passed X, XI & XII standard examination from the institutions situated in the State of Maharashtra will be eligible for admission under 70% (R Quota of his/her region) and 30% (S Quota) on merit basis.
- iii) The candidates who have passed XII standard or equivalent examination (with Physics, Chemistry, Biology or Biotechnology and English) from the institutions situated out of Maharashtra and whose parents are domiciled in Maharashtra, will be eligible for admission under 30 % (S-Quota) on merit basis subject to the condition that he/she should upload the required Domicile/ Residence certificate in the name of his/her parent indicating minimum 3 years stay in preceding 10 years in Maharashtra state issued by Competent Authority from Maharashtra state.
- iv) **Annexure VIII, IX, X, XI & XII** shall have to be submitted by candidate to the Associate Dean of concerned college where he/she has been admitted.



- v) Selection of the eligible candidates for admission to B.V.Sc. & A.H. will be based on the merit/ marks in **NEET-UG-2023** examination.
- vi) No grievances / arguments of the candidates shall be entertained, if he / she fails to get the admission due to his/her own negligence, late reporting, technical difficulties, personal problems etc.

8. LIST OF CERTIFICATES/DOCUMENTS TO BE UPLOADED DURING FILLING OF ONLINE APPLICATION FORM.

A) LIST OF ESSENTIAL CERTIFICATES/DOCUMENTS

The candidates shall upload the following original/clearly legible self attested documents while filling online application form. Before submission of application form, the candidates should ensure that the uploaded documents are clearly visible.

- (a) **Mark sheet / Grade card of qualifying examination.**
- (b) **NEET-UG-2023 Mark sheet**
- (c) **School / College (Last attended) Leaving Certificate.**

If the candidate is presently admitted to any other college / institute and applies for admission for the first year degree course, then the recent Bonafide Certificate issued on or after **01/04/2023** by the competent authority of respected college / institute will be considered.

In respect of candidates who have passed XIIth standard or equivalent examination from the institutions situated out of Maharashtra State, if it is not possible to upload College Leaving Certificate, he/she shall have to upload '**Migration/Bonafide Certificate**' issued on or after **01/04/2023** by respective College/Institute.

However, if such candidate is admitted then he/she shall have to submit College Leaving Certificate within a period of 7 working days failing which his/her provisional admission shall be cancelled.

- (d) **Domicile Certificate/ Residence certificate** issued by the Competent Authority indicating minimum 3 years stay of the candidate or his/her parents in preceding 10 years in Maharashtra state or candidate's School leaving certificate (indicating the place of birth) or Birth certificate.



B) LIST OF CERTIFICATES/DOCUMENTS FOR RESERVATION

- a) **Caste Certificate** in the prescribed format issued by the Competent Authority designated for the purpose in the Maharashtra State.
- b) **Caste Validity Certificate (CVC)** issued by the Competent Authority designated for the purpose in the State. The candidates shall be required to submit the caste certificate, caste/tribe validity certificate or proof of submission of proposal to competent authority for obtaining 'Caste Validity Certificate' along with the application form. However, such candidates who has submitted proof of submission of proposal for CVC shall necessarily required to submit 'Caste Validity Certificate' issued by the competent authority on or before **17/08/2023** as per the schedule of admission programme. The candidate failing to submit CVC even till the last date shall be considered under unreserved category provided he/she fulfills the minimum eligibility criteria for unreserved category candidate.
- c) **Non-Creamy Layer Certificate** for candidates seeking admission under VJ/DT(a), NT(b), NT(c), NT(d), OBC, and SBC categories issued by the Competent Authority on or after **01/04/2023** or valid upto the date of submission of application form.
- d) **Agriculturist Certificate** issued by the Tahsildar or Naib Tahsildar on or after **01/04/2023**. Proforma of this certificate is at **Annexure IV** of the Prospectus.
- e) **Project Affected Person Certificate** issued by the District Resettlement Officer/Rehabilitation Officer of Government of Maharashtra in the prescribed form. Proforma of this certificate is at **Annexure V** of the Prospectus.
- f) **Freedom Fighter Certificate** of the applicant's parents issued under the signature of the Hon'ble Prime Minister of India/ Chief Minister of Maharashtra State along with required affidavit. (Please refer Clause No.6.3 (B) on Page No.10 of the Prospectus).
- g) **Defence Personnel Certificate** from Zilla Sainik Welfare Office/Board/Discharge Certificate from Officer Commanding the Regiment or Serviceman Certificate from the competent authority. clearly indicating period of defence service. (Please refer Clause No. 6.3 (D) on page No.11 of the Prospectus).



- h) The candidates applying for admission under **‘Physically Handicapped Category’** should submit the Certificate of Handicapped issued by the Competent Authority (District Civil Surgeon or equivalent Government Hospital/ Medical Board) designated in this behalf. (Please refer Clause No. 6.5 on page No.12 of the prospectus) Proforma of this certificate is at **Annexure VI** of the prospectus.
- i) **Orphaned Certificate** : The candidate willing to take admission from orphaned category are required to submit Orphaned certificate issued from Commissioner, Women and Child Development on his/her letter head with the signature of Deputy Commissioner (Child Development), Pune / Commissioner, Women and Child Development, Pune. (Please refer Clause No. 6.6 on page No.12 of the prospectus)
- j) **Economically Weaker Section Certificate** issued by the Tahsildar or Naib Tahsildar on or after **01/04/2023**. (Please refer Clause No. 6.7 on page No.12 & 13 of the prospectus) Proforma of this certificate is at **Annexure VII** of the Prospectus.
- k) **‘No-Objection Certificate’** from the Employer in case of In-service Candidate.

Note: If any uploaded document is not clearly visible then reservation/ claim (whichever is applicable) shall not be given.

C. REJECTION OF APPLICATION FORM

Application shall not be considered and shall stand rejected automatically on any one or more of the following deficiencies.

- i) If the **Mark Sheet / Grade Card** of the qualifying examination is not uploaded/not visible.
- ii) If **NEET-UG-2023 Mark Sheet** not uploaded/not visible.
- iii) If the **Leaving Certificate** of School/College/Institute (last attended) **or Bonafide/Migration Certificate** issued on or after **01/04/2023** of School/College/Institute where presently admitted is not uploaded.
- iv) If the prescribed **application fees** is not paid.
- v) If candidate does not fulfill the eligibility for admission.
- vi) The application form of physically handicapped candidates having more than 50% disability shall be rejected.
- vii) Indian Dairy Diploma shall not be considered equivalent to XIIth (HSSC).



9. IMPORTANT INSTRUCTIONS TO NRI/FN/PIO/OCI CANDIDATES

- i) Seats will be filled in over and above intake capacity by NRI/FN/PIO/OCI candidates.
- ii) Candidates who fulfill the eligibility condition of age (17 years completed and should be below 25 years of age on or before **31st December, 2023**) shall be considered for selection on merit basis.
- iii) The candidates should secure 50% marks in the individual subject of Physics, Chemistry, Biology or Biotechnology and English at XII Std. or equivalent examination.
- iv) The candidates who have passed XII Std. or equivalent examination from India must have appeared in **NEET-UG-2023**. However, the candidates who have passed XII Std. or equivalent examination from abroad shall be exempted from **NEET-UG-2023**.
- v) The medium of instruction shall be English only.
- vi) There are no seats for NRI sponsored candidate.
- vii) The NRI/FN/PIO/OCI candidates shall submit the online application form in all respect along with all necessary documents/testimonials.
- viii) The personal presence of the candidate along with all original documents/testimonials on the day of admission/reporting is compulsory, else he/she will not be consider for admission.
 - a) Non Residential Indian (NRI) is a Indian Citizen staying outside India for more than 182 days during year.
 - b) Candidate applying under NRI/Wards of NRI should submit recent NRI status certificate of candidate/parents issued by Indian Embassy/High Commission/Consulate General of the Country concerned with their seal.
 - c) Overseas Citizen of India (OCI) cardholder/person of Indian origin (PIO) should submit necessary proof along with application form.

Before admission the NRI/FN/PIO/OCI candidate will have to apply for appropriate category Indian Visa to the Indian Embassy in their home country. The candidate will have to submit copy of the passport and the visa at the time of admission.



- ix) The Director of Instruction & Dean, Faculty of Veterinary Science, MAFSU, Nagpur shall be Nodal Officer for NRI/FN/PIO/OCI admissions.
- x) The Special Fee for NRI/FN/PIO/OCI candidate is \$ 10000 (U.S. dollar) per professional year throughout degree course in addition to regular fees as per **Annexure III-C**.
- xi) Candidates admitted under Nepal Aid Fund shall have to pay institutional economic fees \$ 2000 (U.S. dollar) per professional year throughout degree course in addition to regular fees of Rs. 59160/- (**Annexure III-C**).
- xii) The selection of the candidate for B.V.Sc. & A.H. Degree programme shall be made on the basis of merit. They should see the final merit list and detail admission programme (**Annexure XIV**) on website (**www.mafsu.ac.in**).
- xiii) The allocation list will be displayed on the website. The intimation regarding the same shall be sent to the candidates on their mobile phone & email address.
- xiv) Candidate shall pay the college and if required hostel fees at the time of confirmation of admission at the respective college.
- xv) Candidate shall be admitted provisionally till he / she registers him/herself in the concerned college where the seat is allotted.
- xvi) The candidate should note that the special fee paid by the candidate for NRI/FN/PIO/OCI quota seat shall not be refunded in any case.

10. ADMISSION PROCEDURE

- i) **The candidates shall read the admission process carefully as stated in the prospectus.**
- ii) The candidate shall apply online, pay the fees, fill up the application form and uploads the desired documents on or before last date of submission of application form.
- iii) **Before submission of application form, the candidate should ensure that the documents are correctly uploaded and readable. Application form completed in all respect and received online on or before the last date of submission of application form shall only be considered for admission.**



- iv) In case any candidate submits more than one application form, the latest filled in application form complete in all respect will only be considered.
- v) Application forms will be primarily scrutinized and the list of candidates with deficient or wrong documents will be displayed on website.
- vi) **Resubmission of deficient documents-** A list of candidates who failed to upload or have wrongly uploaded the desired documents will be displayed on website. These candidates will be required to upload only the indicated documents within the due date specified by the University for resubmission (**Annexure-XIV**).
- vii) Additional documents will not be accepted after due date specified for the purpose of resubmission of deficient documents.
- viii) After final scrutiny, provisional merit list of eligible and list of non-eligible candidate will be displayed on the website (**www.mafsu.ac.in**) as per the scheduled admission programme.
- ix) Candidates aggrieved by the contents of the provisional merit list may prefer an online appeal on or before the last date for submission of grievance as mentioned in admission programme (**Annexure-XIV**) addressed to **The Registrar, MAFSU, Nagpur** in the prescribed online form of grievance application. The candidate shall deposit the grievance application fees **Rs.200/-** (Rupees Two Hundred) in any form as mentioned in the steps earlier. Candidate shall be required to mention the specific reason of grievance.
- x) In case, the documents uploaded by the candidates for constitutional reservation are invalid or rejected by authority, then such candidates if eligible under Unreserved category shall have to pay the difference of application fees (i.e. Rs. 300/-) at the time of submission of grievance for consideration of that candidature under Unreserved category in the final merit list.
- xi) **No additional documents will be accepted along with grievance application form.**
- xii) After receiving the grievance application, the grievance committee will examine the grievances of the candidates on the basis of the documents enclosed along with his/her original online application form and the take



the decision on grievances. The decision of grievance committee shall be final.

- xiii) If the applicant fails to appeal on or before last date for submission of grievance, his/her grievance shall not be considered and no further correspondence in this regard shall be entertained.
- xiv) Final merit list of the eligible candidates will be prepared on the basis of score in **NEET-UG-2023** and will be notified on the website by the competent authority. In case of tie in the score of **NEET-UG-2023**, following levels shall be adopted for deciding the merit :

First Level : A candidate with higher percentage of aggregate marks in XIIth or equivalent examination shall be considered. If the tie still persists then,

Second Level : A candidate with higher marks in Biology at **XIIth** shall be considered. If the tie still persists then,

Third Level : A candidate with higher marks in Chemistry at **XIIth** or equivalent examination shall be considered. If the tie still persists then,

Fourth Level : A candidate with higher percentage of aggregate marks in SSC or equivalent examination shall be considered. If the tie still persists then,

Fifth Level : The age of candidate shall be considered for seniority.

- xv) ***Candidate should note that it is essential for him/her to log in for submission of the option form/preference form for every round of admission. Otherwise he/she shall not be considered for admission during that round.***

- xvi) Region Quota admission round shall be followed by State Quota round. A candidate belonging to a particular region shall not be entitled for admission to the college from the same region in State Quota.

- xvii) Candidates will receive updates on their respective mobile phone and emails, based on the admission process by the University. **However, the candidates shall visit the website (www.mafsu.ac.in) for updates during the whole procedure of admission.** They should not remain dependent on mobile phone messages and email.

- xviii) **First Round of admission** – After receiving the option/preference form, the allocation list will be displayed on website (i.e.www.mafsu.ac.in) and the intimation regarding the same shall be sent to the candidates on their mobile phone & email address.



The allotment letter shall be generated for those candidates who have been allotted the seats. The candidate shall personally visit the allotted college along with the printout of allotment letter, all original documents and admission fees to confirm his/her admission within stipulated period of time.

In case, if any candidate does not report to college to confirm the seat during first round then next candidate from the waiting list of the respective category shall be allotted the seats as per merit.

- xix) **Once the seat is allotted as per candidate's first preference for Region/State Quota Round and the candidate does not report to college within the stipulated period of time mentioned in allotment letter, his/her candidature will be cancelled for next rounds.**

Whereas, if the seat is allotted as per candidate's second preference and onwards and the candidate does not report to college, his/her candidature will be considered for next rounds of admission based on vacancies.

- xx) Candidate shall be admitted provisionally till he / she registers him/herself in the concerned college where the seat is allotted.
- xxi) Candidate, who is admitted but fails to register/join the College within the period given by the Competent Authority or cancels the admission after joining, will not be eligible for admission during subsequent round.
- xxii) Although the category claimed by the candidate is given to him/her in the Final Merit List but during the course of physical verification of the original certificates and documents, if it is noticed that the certificate /document is invalid, then he / she shall not be entitled for the admission during that round. In such case the University may work out the revised merit position of the applicant and will amend the final merit list accordingly and the said applicant shall be considered eligible for admission as per his revised merit in next round of admission.
- xxiii) The admissions to various seats under Regional (R) and State (S) Quota shall be final and once the candidate is admitted he/she will not be eligible for change of College or Quota.
- xxiv) **Second Round of admission** - The seats remaining vacant after first round of Regional as well as State quota admission will be filled in during the second round as per the following stepwise procedure -
- Step I** - Filling of vacant seats separately in reserve and unreserved category as per vacancy position.
- Step II** - Conversion of female seats to male seats separately (if the female candidate of particular category are not available) in reserve / unreserved category.



Step III - Conversion of horizontal reservations into respective reserve & unreserved categories.

Step IV - Filling of vacant seats in reserve categories (if any) by SBC candidates (Max.2%).

Step V - Filling of remaining vacant seats by interse within reserve categories.

Step VI - After filling the vacant seats by step I to Step V if there are any vacancies those will be filled in by Common State merit interse.

Note : After completion of all steps I to VI, the allotment list shall be generated for second round of admission.

xxv) **Third Round of admission** - The seats remaining vacant after second round of Regional as well as State quota admission will be combined and filled in during the third round. In case, if any candidate does not report to college to confirm the seat during third round then next candidate from the waiting list of the respective category shall be allotted the seat as per merit.

xxvi) **Special Round of admission** - The seats remaining vacant after third round of admission will be filled in during the special admission round. In case of any resultant vacancy, the seats will be filled in by candidate as per merit from that respective category.

xxvii) The student who secures admission for the degree course shall have to submit proof of his/her Aadhar Card, Bank Account details and Voter Card with the office of the Associate Dean of the respective college.

xxviii) The candidate admitted under this University shall abide by rules and regulation of this University and changes made therein from time to time.

xxix) Any issue not mentioned in prospectus shall be decided by the Competent Authority of the admission, which shall be final and binding.

xxx) Any candidate if found obstructing the admission process, trying to influence in unlawful manner and / or creating nuisance shall be liable for disqualification from the admission process. The decision taken by the Competent Authority in this respect shall be final and binding.

xxxi) All the admissions shall be deemed as provisional and subject to further scrutiny and verification, if required. Admission shall be liable for cancellation at any stage during the course study of the student, if it is found that the admission was contrary to the rules or invalid by reason of incorrect or false information furnished by the applicant or parents/guardians at the time of admission. Any such cancellation of admission may lead to penal action.



11. CANCELLATION OF ADMISSION :

- i. If a student desires to cancel his / her admission for a bonafide reason, he /she will have to apply to the concerned Associate Dean of the College.
- ii. After receiving duly signed admission cancellation request letter from the candidate, the Associate Dean of the college shall cancel the admission immediately and inform the university regarding vacancy generated due to cancellation.
- iii. If a student cancels his / her admission and applies to the Associate Dean of the College is eligible to get refund of fees as per given below-

Note- a) In case of (1) mentioned in above table, the concern college shall deduct an amount not more than 5% of the fees paid by the student subject to a maximum of Rs.5000/- as processing charges from the refundable amount.

b) In case of (5) mentioned in above table, only the caution money shall be refunded to the student.

However, no refund except caution money will be admissible after cancellation of admission any time during the degree course or completion of degree course.

- iv. If candidate is admitted under NRI/FN/PIO/OCI quota, special fees deposited by such candidate shall not be refunded in any case.



PART- II

1. SYSTEM OF EDUCATION

The total course duration would be of 5 complete professional years (total duration 5 ½ years) comprising of four professional years course work and one year compulsory internship training programme. The University has adopted VCI Minimum Standards of Veterinary Education (MSVE) 2016. In this system, I, II & III professional year shall cover at least 210 days of instruction excluding time spent for annual examinations, while, IV professional year shall consist of 315 instructional days excluding time spent for annual examinations. The internship training programme shall cover 12 calendar months. The candidate admitted to B.V.Sc. & A.H. will have to complete Internship Training Programme as per the rules prescribed in this behalf.

2. REGISTRATION

- i) After receipt of admission allotment letter, candidate will report to the Associate Dean for registration of first professional year.
- ii) Students will have to register in consultation with the counselors.
- iii) The registration forms be submitted in the Academic cell duly filled in and signed by student, counselor and teachers within prescribed time, failing which the admission shall be cancelled.
- iv) In absentia registration shall not be allowed in any case.

- ii) The syllabus comprises of prescribed courses of 81 credits (Theory 50 + Practical 31) as minimum requirement to be covered from 1st to 4th Professional years.

- iii) In addition to the Core Courses, a student shall have to successfully complete the internship including entrepreneurial training for the award of B.V.Sc. & A.H. degree.
- iv) Every student shall have register for (1+0) non-credit compulsory course “Democracy, Election and Good Governance” in first year satisfactory completion of this course is necessary for promotion to second year B.V.Sc. & A.H. degree course.
- v) Remount Veterinary Squadron or National Cadet Corp or Equestrian or National Service Scheme or Sports and Games shall be non-credit (0+1) training programmes. Registration and satisfactory completion of any of these programmes during all the professional years (except fourth) shall be compulsory for the award of B.V.Sc. & A.H. degree.
- vi) Every student of B.V.Sc. & A.H. degree course shall be required after passing the fourth professional year examination to undergo compulsory rotating internship to the satisfaction of the University for a minimum period of twelve calendar months so as to be eligible for the award of B.V.Sc. & A.H. degree.
- vii) Every student of B.V.Sc. & A.H. degree course shall purchase the essential accessories *viz.* apron, gum boots, dangri, stethoscope, thermometer etc. for their safety during farm / clinic activities.

4. ATTENDANCE

Minimum 75% attendance is essential in the classes of theory and practical separately. Students should be fully aware that they will not be allowed to appear for the annual examination (including compartmental) of that course if they do not attend minimum 75% classes of theory and practical separately.

5. HOSTEL ACCOMMODATION

Hostel accommodation for a limited number of students is available at the hostels of the colleges of the University. Every student admitted to constituent colleges may not necessarily be given hostel accommodation. Hostel accommodation will not be a right of the student.



6. DISCIPLINE

- a) The cases of unfair means and the cases of misbehavior will be dealt with as per Maharashtra Animal & Fishery Sciences University, Nagpur (Maintenance a discipline and good conduct by students rules, 2002 and hostel rules, 2002) and as amended from time to time.
- b) Bonafide students of the colleges if allegedly found involving in activities like ragging, bullying or kidnapping and any other act of indiscipline shall immediately be suspended from the college as well as the hostel without any notice by the Associate Dean of the College and are liable to be expelled from the college by the Vice-Chancellor on the detailed report of the Registrar of the University as per provision.
- c) As per the provision of Maharashtra Act XXXIII known as “Maharashtra Prohibition of Ragging Act of 1999”, student indulging in ragging will be punished under the Act resulting in suspension, expulsion from the College and imprisonment.
- d) If any incident of ragging comes to the notice of the authority, the concerned student will be given liberty to explain and if is explanation is not found satisfactory, the authority would expel him / her from the institution.
- e) The UGC regulation on curbing the menace of ragging in Higher Education Institution, 2009, shall be applicable to all admitted candidates. The Annexure VIII & IX shall have to submitted by candidate to Associate Dean of concerned college where he/she has been admitted.

7. ACADEMIC REGULATION

Every students admitted to B.V.Sc. & A.H. Degree Course shall have to abide by the existing Academic Regulations for the said degree programme and / or as amended from time to time. The students once admitted, are advised that they should necessarily read the Academic Regulations available at the college.

a) **Migration / Transfer of student from one Veterinary College to another :**

1. A student studying in a recognized veterinary college may be allowed to migrate/ be transfer to another recognized veterinary college under another/same University.
2. The migration/transfer may be allowed by the University concerned after passing 1st year B.V.Sc. & A. H. degree course within one month of the start of academic session of 2nd year of the receiving college/University. In such cases, the incumbent has to apply to the Registrar within one month after passing 1st year B.V.Sc. & A.H. through the Dean/Associate Dean of the college/institute. The Registrar may then, admit (on transfer basis) the said student, subject to availability of vacancy.
3. Migration/transfer of a student shall not be allowed in the mid of an academic year.



4. The number of students migrating/transferring from one veterinary college to another veterinary college during the period of one academic year will be kept to the maximum limit of 5 per cent of its intake capacity of each of the veterinary colleges in one year.
5. Transfer of student, however, will not be permitted in case of student who has been expelled by the authority of the University or constituent or affiliated college as a punishment for act of misconduct.
6. The students admitted under NRI/FN/PIO/OCI; J & K and Ladakh UT and Goa Quota will not be eligible for Inter collegiate / University transfer.
7. The students failed in first attempt in first year will not be eligible for Inter collegiate / University transfer.

b) Medical examination

1. Medical examination shall be compulsory for all the students admitted during the first year and the same should be got done from the Civil Surgeon/Medical Officer/ Registered Medical Practitioner as directed by the University/Associate Dean within 6 months of commencement of first professional year. If a student is medically unfit, the Associate Dean will inform the concerned student and his/her parents/guardian for rectification of the defects. If a student is found medically unfit, he/she is liable to be discontinued from the University. Such cases would be reported to the Registrar for taking necessary action. Refund of fees shall not be applicable in such cases.
2. If a student fails to appear for the medical examination arranged by the University/ Head of the Institute, he/she will have to get himself/herself medically examined from the above-mentioned medical authority at his/her own expenses and produce examination report within the period specified by the college authorities. In case, he/ she fails to produce the medical examination report within the specified time, his/her admission shall stand cancelled.
3. At any time during the course of the degree programme, the student may be directed to get himself/herself medically examined by the competent authority(s) as & when it may deem fit.

c) Maximum Duration

The student shall have to complete his/ her studies within 9 academic years (excluding internship) from the date of his/her admission. In no case, a student shall be allowed to continue his/her B.V.Sc. & A.H. studies beyond 9 academic years (excluding internship) in a veterinary college.

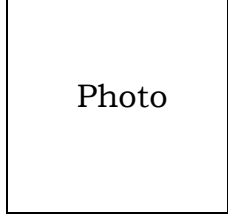
